

Notice to Canadian Clients

Reliance on International Dealer Exemption pursuant to subsection 8.18(2) and the International Adviser Exemption pursuant to subsection 8.26(3) (the "Exemptions") of National Instrument 31-103 Registration Requirements, Exemptions and Ongoing Registrant Obligations ("NI 31-103") and Notification to Permitted Clients of the prescribed information under subsection 8.18(4)(b) and 8.26(4)(e) of NI 31-103

This disclosure is in connection with your account(s) and transactions with, and relevant services and products offered by or through Rockefeller Financial LLC., a broker-dealer and registered investment adviser registered with the US Securities Exchange Commission, Member FINRA, SIPC.

Please note that as a client domiciled in Canada, when Rockefeller Financial LLC trades with you or provides advice it does so in reliance upon the Exemptions from the dealer registration requirement and adviser registration requirements under NI 31-103 (as such Exemptions may be amended and restated from time to time). Pursuant to the Exemptions, Rockefeller Financial LLC is subject to trading and advising restrictions, including, among other things, that it is only permitted to trade in or provide advice on "foreign securities" with "permitted clients" (as defined in NI 31-103) resident in Canada.
